EXPECTED ATTENDANCE

The RIDS Annual Fall Conference attracts attendees from Rhode Island and neighboring communities. The expected attendance is 75 attendees, including dermatologists, dermatology professionals and trainees (fellows, residents and medical students). We are also expecting 20 exhibiting companies to attend from various industries.

EXHIBIT HALL

The Exhibit Hall at the RIDS Fall Conference is a large event space located adjacent to the General Session meeting room in accordance with Accreditation Council for Continuing Medical Education (ACCME) guidelines. All meals and breaks will take place in the Exhibit Hall.

Exhibit tables are assigned based on exhibitor level and date of agreement/payment received. Please note that there are a limited number of exhibit tables available.

Rhode Island Dermatology Society is a 501(c)6 organization, the Tax ID# is 45-4893704.

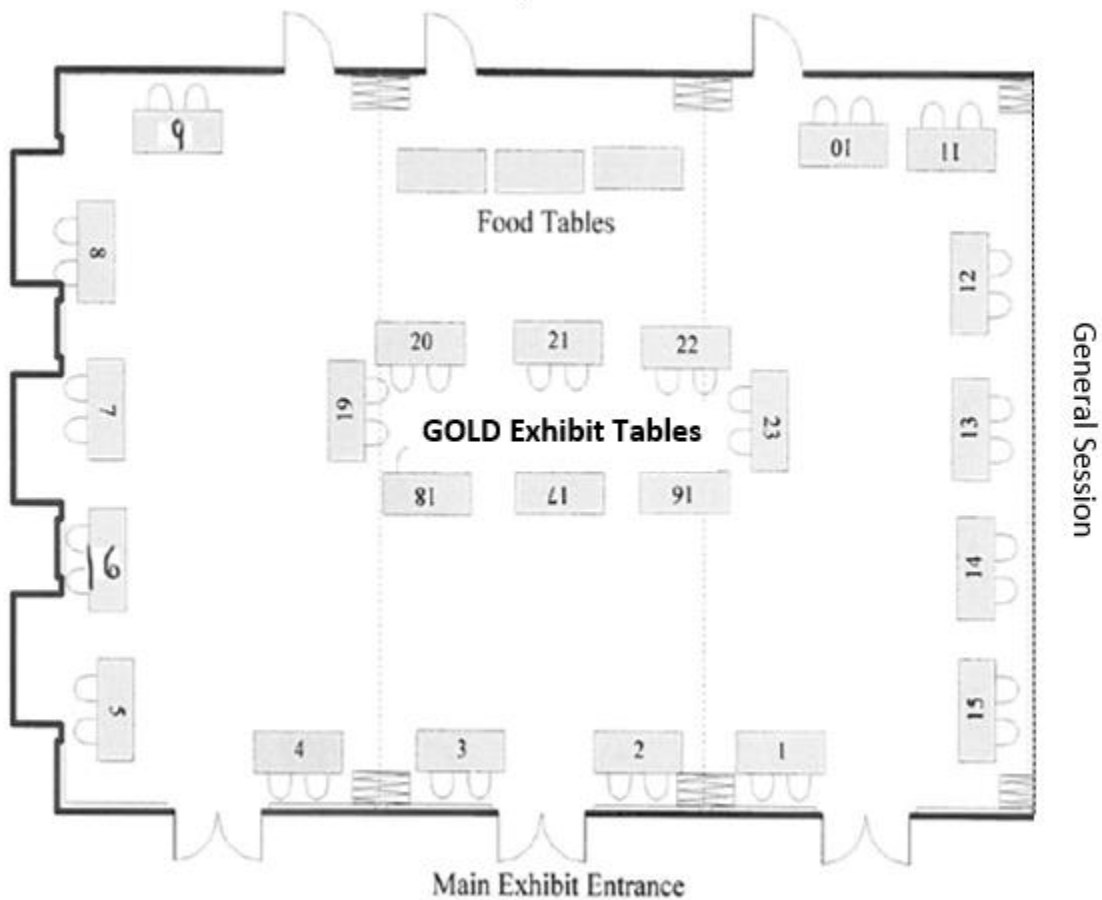
By applying for exhibit space, the applicant agrees to adhere to all conditions and regulations outlined by the Accreditation Council for Continuing Medical Education (ACCME) and in the Exhibitor Prospectus. RIDS requests full cooperation of the exhibitor. Please be sure that everyone involved in the arrangements for your exhibit has a copy of these rules and regulations. It is the responsibility of the exhibitor to see that all booth staff are aware of and adhere to these rules and conduct themselves in a professional manner throughout this meeting.

1. **Criteria for Acceptance:** Permission to exhibit may be granted to firms if their proposed exhibit meets the following criteria: a) Relevant to the practice of dermatology; b) Contribute to the educational goal of the Annual Fall Conference; c) Perform in accordance with the claims made by the applicant; and d) Are safe when used in accordance with the instructions or recommendations of the applicant.
2. **Exhibitor Registration:** All representatives of exhibiting companies must register prior to entrance into the Exhibit Hall. A name badge with company name must be visible at all times.
3. **Payment Information:** Payment must be received by September 6th, or RIDS reserves the right to release booth space to companies on the waiting lists. Checks should be payable to the RIDS Society, and mailed to 44 Concord Road, Marlborough, MA 01752. RIDS also accepts all major credit card payments. No booth space will be reserved until payment is received by the RIDS office. No refunds will be made after August 6th.
4. **Shipping:** Vendors are responsible for all arrangements in the shipping of exhibits. Please bring your company's own shipping forms and account number in order to make your own shipping arrangements. Additional shipping information will be provided in the exhibitor confirmation packet.
5. **Electrical Needs:** To receive electrical access, advance notice must be given to the RIDS Office for arrangements to be made through the hotel event coordinator.
6. **Liability/Insurance:** Neither the Rhode Island Dermatology Society nor its meeting site assume responsibility for any loss, injury or damage occurring to an exhibitor or any exhibitor's property. It is the exhibitor's responsibility to have their person/materials insured against theft, damage, loss or injury.

MEETING FLOOR PLAN – EXHIBIT HALL & GENERAL SESSION

The Grand Ballroom is a collection of five meeting rooms. The General Session will take place in the College/Sessions rooms (on the right). The Exhibit Hall will take place in the Angell/Benevolent/Canal Rooms. A solid partition will separate the two meeting spaces.

Below is the sample floor plan layout. Once the final layout is confirmed, RIDS will contact the exhibitors for their preferred booth. This will be based on Exhibit Level and order of registration.
